Overview

Lockyer District State High School recognises as its prime obligation, the provision of access to an appropriate educational service for students whose primary place of residence is within the school's catchment area.

The School EMP is supported by:

- School Enrolment Management Plan (School EMP) procedure

Local Catchment Area

A school's local catchment area is the geographical area from which the school is to have its core intake of students. To view the School's Catchment Map (EdMap) and Enrolment Management Plan please go to our website www.lockyerdistrictshs.eq.edu.au/enrolments

Verification of proof of permanent residency within our Lockyer District State High School catchment area will be required prior to submitting your enrolment application form. Documents which can be provided as proof of residency include:

- Drivers Licence
- Rates Notice
- Rental Notice
- Utility bill e.g. water, electricity
- Other bills e.g. phone/internet

As part of the verification process, the Principal may conduct checks to ensure the residency information provided to the school is accurate. This may include a physical address check to verify the residential information provided.

The Principal may decide to repeal a child's enrolment if any false or misleading information or documents are provided during the enrolment application process and the child is not otherwise entitled to be enrolled at the school.

Applicants should note that a false statement/assertion about the student's principal place of residence may constitute as fraud and can be reported to police to be investigated.
